Today Eureka Group Holdings Limited (ASX:EGH) (**Company**) issued 12,255,383 shares at 54.0 cents per share (**Shares**) to institutional investors as part of a capital raise for further freehold village acquisitions. The Shares are comprised of:

- (a) 12,162,790 shares, which form the remaining part of the \$10.35m capital raise previously announced to the market on 16 October 2015 and which were approved by shareholders at the Company's recent AGM; and
- (b) 92,593 shares for capital raised at the same time and purpose as (a), but which are issued under the Company's 15% cap.
