Cleansing notice under section 708(5)(e) of the Corporations Act

Eureka Group Holdings Limited (“Eureka” or the “Company”) advises that it has issued 2,517,573 fully paid ordinary shares in the Company (Shares) today at an issue price of \$0.5862 to shareholders pursuant to the Company’s fully underwritten Dividend Reinvestment Plan.

For the purposes of section 708A(6) of the Corporations Act 2001 (Cth) (Corporations Act), Eureka gives notice that:
